**INFORMATION ON PERSONAL DATA PROCESSING**

The controller of your personal data is the Polish Arbitration Association (hereinafter "Association"), ul. Rondo ONZ 1, 00-124 Warsaw, e-mail: [personaldata@polisharbitration.pl](mailto:personaldata@polisharbitration.pl).

We process your personal data for the following purposes:

- (a) acceptance as members, as well as exercising the rights and fulfilling obligations of the members (Article 6(1)(a) GDPR);
- (b) performance of statutory tasks, especially those requiring contact with the Members, e.g. Invitations to events organized by the Association (Article 6(1)(f) GDPR);
- (c) fulfilment of the Association's legal obligations (Article 6(1)(c) GDPR);
- (d) establishment or assertion of claims or defence against claims (Article 6(1)(f) GDPR).

The provision of the data is voluntary, but necessary to accept Members, as well as to exercise rights and perform obligations as a Member of the Association. You may file an objection to the processing of your personal data at any time if the basis of the processing is a legitimate interest or a public interest. In such a situation, we shall stop processing your personal data for the above objectives unless we demonstrate that (a) there are valid, legally justified grounds which are overriding with respect to your interests, rights and freedoms or (b) the data will be necessary to possibly determine, assert or defend against claims.

We shall process the data as long as you are a Member of the Association, until your liabilities are settled and during the limitation period related to these liabilities. However, your personal data, which is processed in order to fulfil the Association's legal obligations, will be stored for the period required by the provisions of the law.

Your personal data may be disclosed to authorized personnel and entities providing services (e.g. couriers and banks), IT support, legal assistance and accounting support. Your personal data is not made available to data recipients from outside the European Economic Area. When processing your personal data, we do not make automated decisions and, in particular, we do not conduct profiling.

You are entitled to access the data and receive copies of your data; you have the right to rectify (correct) your data; the right to erase data; the right to restrict the processing of the data; the right to transfer the data; the right to withdraw your consent if the processing takes place on the basis of a consent; the right to file a complaint with the President of the Personal Data Protection Office or another appropriate supervisory authority. Please remember that we shall need to confirm your identity before you can exercise your rights.
